Last May 22 to 23, 2018, Ms. Stéphanie Carette the Program Manager of the European Union (EU) Philippine Delegation together with PhilDHRRA representatives and implementing NGO partner St. Catherine Family Helper Inc. (SCFHI) met with local Civil Society Organization (CSO) representatives in the three projects sites of CCCE PAG-PR in the province of Negros Oriental.

CCCE PAG-PR or Consolidating CSO network for Citizen Engagement towards Participatory and Accountable Governance for Poverty Reduction is a 3-year project being implemented by Philippine Partnership for the Development of Human Resources in Rural Areas (PhilDHRRA) in partnership with Affiliated Network for Social Accountability in East Asia and the Pacific (ANSA-EAP), and local implementing NGO partners (INPs) funded by the European Union. The project has 27 municipal project areas in 9 provinces in the Philippines. Currently, the project is in the last year of implementation and is focusing on citizens' led monitoring.
